May kindly see the property statement online received from Sri Sanjiv Pandey, District & Sessions Judge, Baghpat regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2016-18 (2016-17 & 2017-18), Total Income from salary is Rs.50,76,229/- and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax (TDS), PPF, Insurances and the balance of his savings bank account(s) is enhanced by Rs.1,45,593/- this financial year from previous year's balance, total of which is Rs.22,91,010/-. Thus, a sum of Rs.27,85,219/- was available with him to meet out the household expenditure of his family consisting of five members in both of the financial years.

It is pertinent to mention here that his wife Smt. Vibha Pandey is Director APPERF & partner in M/S Jalandhar Petrol Service Station with Annual Income- Rs.3768314/- for Financial year 2016-17 & annual income Rs.4248780/- for 2017-18.

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2014-16 online and same has been processed before the Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Baghpat Judgeship on old case Id no-3784.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-18 (2016-17 & 2017-18) vide online dated 07.12.2021. As such, there is delay in submitting the same. In this regard officer has not given any reason for delay submission.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Sanjiv Pandey, District & Sessions Judge, Baghpat be laid before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Baghpat for His Lordship's kind perusal and orders?
