May kindly see the property statement online received from Sri Virendra Kumar-IV, Addl. Civil Judge (Senior Div.), Bahraich regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2016-18 (2016-17 & 2017-18), his gross income from salary is Rs.8,57,750/- and total deductions/Savings/investments against Savings, GIS, Income Tax and Repayment of home loan is Rs.3,79,679/-. The balance of Rs.72,669/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.4,78,071/- was therefore available for himself to meet out the household expenditure in the financial years 2016-18 (2016-17 & 2017-18).

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of Joining into U.P. Judicial Service online against case id-P00008482020 (Old Case Id :1712) and same has been processed before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Bahraich Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-18 (2016-17 & 2017-18) vide online dated 11.12.2021. As such, there is delay in submitting the same. In this regard, officer verbatim: "It is most respectfully submitted that due to certain unavoidable reasons and due to misplacement of certain bank and loan related documents, the same could not be sent earlier, for which I convey my sincere apologies and undertakes to adhere to timely submissions of the same in the near future."

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Virendra Kumar-IV, Addl. Civil Judge (Senior Div.), Bahraich, be laid before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Bahraich Judgeship for His Lordship's kind perusal and orders?
