In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-18 (2016-2017 & 2017-2018) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2016-18 (2016-2017 & 2017- 2018), Gross income from salary is Rs. 8,54,600/- and total deductions repayment/ savings/ investment against GIS, NPS, PPF and the balance of his savings bank account(s) is enhanced by Rs.24,112/- this financial year from previous year's balance, total of which is Rs.66,053/-. Thus, a sum of Rs.7,88,547/- was therefore available with him to meet out the household expenditure of his family consisting of five members in both of the financial years.

In this connection, it is submitted that the officer has already submitted his property statement related to joining which has been processed online & a separate note has been made on eservice-Id no. P00016822021 (Old Case Id: 3799) has been placed before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Saharanpur for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-2017 & 2017-2018) in its next financial year i.e., 2016-18 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-18 (2016-2017 & 2017-2018) vide online dated 10/12/2021. As such, there is delay in submitting the same. In this regard, officer has stated that due to mistake he could not submit the property statement in time. He has apologized for the same.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-2017 & 2017-2018) of Shri Mayank Prakash, Addl. Civil Judge (Senior Division)/ ACJM, Saharanpur, be laid before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Saharanpur for His Lordship's kind perusal and orders?
