

## **I/C Joint Registrar (J)(Budget)**

May kindly see the online office note dated 10.2.2023 regarding submission of statement of movable and immovable properties for the financial years 2010-12 (2010-11 & 2011-12) of Sri Sunil Kumar Singh-II, Additional District & Sessions Judge (POCSO), Hardoi which was submitted before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Hardoi Judgeship for kind perusal and orders. On the aforesaid office note His Lordship's has been pleased to order as under:

"This property statement relates to the financial years 2010-2011 and 2011-2012.

As per the report of the Incharge Joint Registrar (J) the statement had to be submitted by March, 2013 but the same has been submitted on 08.12.2021. The delay in submitting the statement has been indicated as highly regrettable and that in future the Officer would submit the property statement well within time.

Perusal of other property statements, as have been submitted by the officer concerned, would indicate that for the subsequent financial years also i.e. 2012-2013, 2013-2014, 2014-2015, 2015-2016, 2016-2017 and 2017-2018, the property statements have been submitted on 08.12.2021. Incidentally, the statement for the financial years 2018-2019 and 2019-2020 which was to be submitted by March, 2021 has still not been submitted.

No reason has been given by the officer concerned as to why the property statements have not been submitted within time rather he has indicated that in future he would be submitting the statements within time. Despite the said statement it is not understood as to why the statements for the financial years 2018-2019 and 2019-2020 were not submitted by the officer concerned within time i.e. by 31.03.2021.

In this view of the matter, office is required to call for a detailed explanation of the officer concerned within four weeks for non-submission of the statements in time and for having resiled from his statement that he would submit the statements in future in time."

So an objection dated 24.03.2023 was raised and in reply to this objection, the officer has submitted his clarification which is placed below in verbatim:

"Kindly take the reference of the above mentioned subject, it is humbly submitted that, I have submitted my property statements on the e-services portal of the Hon'ble High Court, Allahabad for the Financial Year 2008 to 2010, Financial Year 2010 to 2012, Financial Year 2012 to 2014, Financial Year 2014 to 2016, Financial Year 2016 to 2018 and Financial Year 2018 to 2020.

It is pertinent to mentioned here that I have already submitted my property statement for the Financial Year 2018-2019 & 2019-2020 through e-services portal vide Case Id-P0001964202/Old Case Id- 4089 Presenting Showing status "Keep on Record"

It is humbly submitted that due to bona-fide mistake & heavy workload delay in submission of the aforesaid property statements of Financial Years 2008-10, 2010-12, 2012-14, 2014-16, 2016-18. is highly regretted.

I sincerely apologize for not sending aforesaid statements in time, I assure that in future, I shall be sending my property statements regularly in time."

May, if approved, the movable and immovable property statements for the financial years 2010-12 (2010-11 & 2011-12) alongwith reply of Court's Order as desired by the COURT in the matter, furnished by Sri Sunil Kumar Singh-II, Additional District & Sessions Judge (POCSO), Hardoi be laid before Hon'ble Mr. Justice Saurabh Shyam Shamsbery, Administrative Judge, Hardoi Judgeship for His Lordship's kind perusal and further orders?
