May kindly see the property statement submitted online dated 24.11.2019 received from Sri Ram Kishor-III, the then Additional District & Sessions Judge/ F.T.C., Maharajganj presently posted as Additional District & Sessions Judge, Mathura regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2016-17, income from salary is Rs.14,27,753/- and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, LIC, PPF a/c, Mutual fund and the balance of his savings bank account(s) is enhanced for Rs.3,10,611/- this financial year from previous year's balance, total of which is Rs.11,22,524/-. Thus, a sum of Rs.3,05,229/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year.

In this connection, it is submitted that Sri Ram Kishor-III has already submitted his property statement upto the financial year 2015-16 which had already been seen by Hon'ble Mr. Justice Om Prakash-VII, the then Administrative Judge, Maharajganj in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial years 2016-17 vide online dated 24.11.2019. As such, there is delay in submitting the same from the part of the officer for which no explanation has been submitted by him.

Hon'ble The Administrative Committee vide minutes dated 11.02.2011 has resolved that- "The property statements be submitted before The Hon'ble Administrative Judge of the district where the officer is posted".

May, therefore, if approved, property statements for the financial year 2016-17 of Sri Ram Kishor-III, Additional District & Sessions Judge, Mathura be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Mathura Judgeship for His Lordship's kind perusal and orders?
