May kindly see the property statement submitted online dated 10.12.2021 received from Sri Nitesh Kumar Sinha, Chief Judicial Magistrate, Varanasi, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2017-19 (2017-18 & 2018-19), income from salary is Rs.20,40,645/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, PPF a/c and the balance of his savings bank account(s) is enhanced for Rs.2,447/- this financial year from previous year's balance, total of which is Rs.7,04,894/-. Thus, a sum of Rs.13,35,751/- was therefore available with him to meet out the household expenditure of his in both the financial years.

It is pertinent to mention here that Sri S.N.Sinha (father) govt. school teacher Annual income 6,00,000/approx and Mrs. Pooja (wife) Advocate Annual income 3,50,000/approx.

In this connection, it is submitted that Sri Nitesh Kumar Sinha has already submitted his property statement online upto the financial years 2015-17, which had already been processed by Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Varanasi on old case ID no.3818.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-19 (2017-18 & 2018-19) vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer for which he apologizes for the delay and ensure that he will submit statement on time in future.

May, therefore, if approved, property statements of the financial years 2017-19 (2017-18 & 2018-19) of Sri Nitesh Kumar Sinha, Chief Judicial Magistrate, Varanasi, be laid before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders?
