May kindly see the property statement submitted online received from Sri Harendra Kumar Ojha, Additional District & Sessions Judge(FTC), Kanpur Nagar, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2015-17 (2015-16 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2015-17 (2015-16 & 2017-18) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2015-17 (2015-16 & 2017-18), his Total income from salary & other source is Rs.24,15,686/- (income from salary is Rs.23,18,771/- & income from maturity amount of LIC is Rs.96,915/-) and total deductions/savings/investments against GPF, GIS, Income Tax, PPF, Repayment of Housing Loan & Personal Loan, LIC Policy and SSY Rs.12,59,047/- (including enhancement of Rs.68,316/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs.11,56,639/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years.

It is pertinent to mention here that his father is retired govt. employee, Pension apprx. 27,000.- per month and his wife is Primary School Teacher (From 02 July 2009) - Basic pay Rs. 9300-34800.

In this connection, it is submitted that the officer has already submitted his property statements offline upto the financial year 2013-15, which is also seen by Hon'ble Mr. Justice Shashi Kant Gupta, the then Administrative Judge, Allahabad Judgeship in Misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2015-17 (2015-16 & 2017-18) in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements for the financial years 2015-17 (2015-16 & 2017-18) firstly vide his application dated 14.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, he stated that he could not submit his property statement in time due to illnesss of old age father who is heart patient.

May, therefore, if approved, property statements for the financial years 2015-17 (2015-16 & 2017-18) of Sri Harendra Kumar Ojha, Additional District & Sessions Judge(FTC), Kanpur Nagar, be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar for His Lordship's kind perusal and orders?
