May kindly see the property statement submitted online dated 10.12.2021 received from Sri Nitesh Kumar Sinha, Civil Judge (Senior Division), Varanasi, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2015-17 (2015-16 & 2016-17), income from salary is Rs.15,09,979/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, LIC policies, PPF a/c and the balance of his savings bank account(s) is enhanced for Rs.1,90,991/- this financial year from previous year's balance, total of which is Rs.5,99,233/-. Thus, a sum of Rs.9,10,746/- was therefore available with him to meet out the household expenditure of his family consisting two members in both the financial years.

It is pertinent to mention here that Sri S.N.Sinha (father) govt. school teacher Annual income 600000/approx.

In this connection, it is submitted that Sri Nitesh Kumar Sinha has already submitted his property statement online at the time of joining into U.P. Judicial Service, which had already been seen by Hon'ble Mr. Justice Manoj Kumar Gupta, the then Administrative Judge, Varanasi on old case ID no.549.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements of the financial years 2015-17 (2015-16 & 2016-17) vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has not given any reason.
