May kindly see the property statement online received from Sri Vikas Srivastava-II, Additional District & Sessions Judge, Aligarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2011-13 (2011-12 & 2012-13) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2011-13 (2011-12 & 2012-13) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2011-13 (2011-12 & 2012-13), Total income from salary is Rs.14,42,224/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax, PPF, LIC, NSC, Bond, repayment of car loan, total of which is Rs.6,88,253/-. Thus, a sum of Rs.7,53,971/- was available with him to meet out the household expenditure of his family consisting of two members in both of the financial years. And the balance of his savings bank account(s) is reduced by Rs.13,536/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement of the financial years 2009-11, which has already been processed online before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Aligarh on old case ID no.3619.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2011-13 (2011-12 & 2012-13) in its next financial year i.e., 2013-14 upto March 2014. He has submitted movable and immovable property statements of the financial years 2011-13 (2011-12 & 2012-13) vide online dated 10.12.2021. As such, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, officer has stated that due to ill-health of his mother and other family members, he could not send the aforesaid property statement earlier. He sincerely submits his apologizes for the same.

May, therefore, if approved, property statements for the financial years 2011-13 (2011-12 & 2012-13) of Sri Vikas Srivastava-II, Additional District & Sessions Judge, Aligarh be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
