May kindly see the online reply dated 05.09.2023 received from Sri Aviral Umrao, Addl. Civil Judge (Junior Div.), Mathura, in compliance of order of Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Mathura in the matter of property statements held at the time of entering i.e., of joining into U.P. Judicial Service, communicated to the officer.

In this connection, it is submitted that the officer had submitted his movable & immovable property statements held at the time of entering i.e., of joining into U.P. Judicial Service, which was put up before Hon'ble the Administrative Judge, Mathura through detailed office note dated 18.05.2023, on which His Lordship has been pleased to pass the following order dated 29.06.2023:

"Call the reason for delay in submission of property statement from the officer."

The order of the Court had been communicated to the officer concerned on 07.07.2023.

In reply/compliance of the Hon'ble Court's Order, the officer concerned has stated that:

"I sincerely apologize for the delay in submitting my property statement as per the stipulated guidelines and timelines.

The delay was unintended and was due to a series of unforeseen personal challenges that arose. I faced unexpected personal exigencies which diverted my attention momentarily. I deeply regret that amidst these challenges, there was an oversight regarding the timely submission of the property statement.

I comprehend the magnitude of my lapse, especially given the stature and sanctity of our institution, and I understand the importance of maintaining transparency and adhering to the guidelines set by the Hon'ble High Court. I assure you that this delay was not a result of neglect or disregard for the protocols, but rather an unfortunate convergence of events.

Once again, I extend my heartfelt apologies for this oversight. I am committed to ensuring that such lapses do not recur in the future. I deeply value the tenets of our judicial system, and I remain devoted to upholding its honour and integrity.

I kindly request your understanding in this matter and assure you of my best intentions and commitment at all times."

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement held at the time of joining into judicial service just after joining into U. P. Judicial Service. His joining date is 16.11.2019. He has submitted the aforesaid statement firstly on 10.12.2021. As such, there is delay in submitting aforesaid property statement from the part of the officer. In this regard, officer has given reason and compliance the Hon'ble Court's order.

May therefore, if approved, movable & immovable property statement held at the time of entering i.e., of joining into U.P. Judicial service alongwith the reply/ compliance of Hon'ble Court's order, as desired by the Court in the matter, furnished by Sri Aviral Umrao, Addl. Civil Judge (Junior Div.), Mathura, be laid before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Mathura Judgeship for His Lordship's kind perusal and orders?
