May kindly see the property statement online received from Smt. Poonam Singh-II, ADJ(FTC), Ambedkar Nagar at Akbarpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2017-19 (2017-18 & 2018-19), her gross income is Rs.34,17,351/- and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, FD, RD, PPF and Insurances are Rs.19,54,192/-. The balance of Rs.4,48,867/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.14,63,159/- was therefore available with her to meet out the household expenditure of her family consisting three members in the financial years 2017-19 (2017-18 & 2018-19).

It is pertinent mention here that's Officer's Husband (Additional District & Sessions Judge, Ambedkar Nagar) having annual income was Rs.14,07,458/- for the financial years 2017-18 & Rs.20,99,711/- for the financial year 2018-19 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2015-17 offline, which had already been seen by Hon'ble Mr. Justice P.K.S. Baghel, the then Administrative Judge, Ghaziabad Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She had submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide online dated 09.12.2021 on eServicesJo portal. As such, there is delay in submitting the same. In this regard, officer verbatim: "Seeking unconditional apology for being late to submit property statement. I shall be vigilant in future in this regard."

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Smt. Poonam Singh-II, ADJ(FTC), Ambedkar Nagar at Akbarpur be laid before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Ambedkar Nagar Judgeship for His Lordship's kind perusal and orders?
