May kindly see the property statement online received from Sri Mohinder Kumar, Additional District & Sessions Judge, Ayodhya regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), his gross income from salary, allowances and Arrears of LLM advance increment are Rs.44,00,441/- and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, NSC, Ra-payment of home loan & Car loan and Mutual Fund (SIP) are Rs.28,42,639/-. The balance of Rs.7,00,027/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.15,57,802/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2018-20 (2018-19 & 2019-20).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2016-18 (2016-17 & 2017-18) in the Misc. file of the officer (offline mode), and same has been processed before Hon'ble Mr. Justice Jaspreet Singh, Administrative Judge, Ayodhya/Faizabad Judgeship for His Lordship's kind perusal and orders in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide online dated 06.12.2021. As such, there is delay in submitting the same. In this regard, officer verbatim: *"It is most respectfully submitted that due to my transfer on promotion in the month of July 2019 and thereafter on attachment at J.T.R.I Lucknow, the desired information could not be submitted in time. It also submitted that due to Covid Pandemic, the desired information from the banks were difficult to obtain, this has also caused delay in submitting the aforesaid information . I deeply regret with folded hands for the late submission of property statement."* 

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Mohinder Kumar, Additional District & Sessions Judge, Ayodhya be laid before Hon'ble Mr. Justice Jaspreet Singh, Administrative Judge, Ayodhya/Faizabad Judgeship for His Lordship's kind perusal and orders?
