May kindly see the property statements online received from Sri Mahendra Kumar Pandey, Additional Chief Judicial Magistrate (Railway), Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income from salary is Rs.17,27,761/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Insurance policies and the balance of his savings bank account(s) has been enhanced for Rs.21,975/- this financial year from previous year's balance, total of which is Rs.5,74,984/-. Thus, a sum of Rs.11,52,777/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement at the time of joining into Judicial Service which had already been seen by Hon'ble Mrs. Justice Sunita Agarwal, the then Administrative Judge, Banda with the warning issued to the officer to remain careful to submit property statement on time, placed in the misc. file of the officer. And for the property statements of the financial years 2016-18, a detailed office note has been laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders on eService ID P00002412019.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-19 & 2019-20 vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has *prayed to condone the delay if any caused on his end due to heavy work pressure and lack of sufficient information,* mentioned in his reply dated 03.11.2023.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Mahendra Kumar Pandey, Additional Chief Judicial Magistrate (Railway), Varanasi be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders?
