May kindly see the online property statements received from Sri Sanjeev Kumar Tyagi, Presiding Officer, Motor Accident Claims Tribunal, Bahraich regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2017-18 & 2018-19 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2017-18 & 2018-19, Total income from salary is Rs.40,93,248/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, PPF, Income Tax, Insurance policies, Home loan, down payment against house purchase and FD are Rs.32,08,486/-. Thus, a sum of Rs.8,84,762/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) has also been reduced for Rs.5,30,374/- this financial year from previous year's balance.

It is pertinent to mention here that his wife's annual income is Rs.1.5 to 2 lacs from beauty parlour for the F.Y.2017-18 & 2018-19.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2016-17 which had already been seen by Hon'ble Mr. Justice Vipin Sinha, the then Administrative Judge, Moradaabad, placed in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 firstly vide online dated 06.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "the property statement of the financial year 2017-18 was to be submitted through e-mode regarding which the applicant had no knowledge and the concerned staff of computer section also did not have much knowledge. After that in March,2020 Corona started and Courts closed down for more about 7 or 8 months. When the Courts opened in July & August, 2020 the complete staff did not come to the Court and when the regular works started he was transferred to Sonbhadra on 03.11.2020 from Moradabad. After that, he had to face several problems of residence here also and he fell ill due to corona in April-May, 2021. Things settled down after corona and he also settled down and today expeditiously as possible, he is sending his annual property statements. He has also prayed that due to the reasons mentioned above the delay in filing annual property statement be condoned taking a lenient view and applicant assures that such delay will not be committed in future.", mentioned in his attachment letter dated 06.12.2021

May, therefore, if approved, property statements of the financial years 2017-18 & 2018-19 of Sri Sanjeev Kumar Tyagi, Presiding Officer, Motor Accident Claims Tribunal, Bahraich be laid before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Bahraich Judgeship for His Lordship's kind perusal and orders?
