

## **Registrar(J)(Budget)**

May kindly see the online property statement received from Sri Ram Mani Pathak, Additional Principal Judge, Family Court, Sitapur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2017-18 & 2018-19, Gross Income from salary are Rs.30,94,616/- and total deductions/ repayment/ savings/ investment against GIS, LIC policies, Income Tax, CPF and PPF are Rs.10,77,423/-. Thus, a sum of Rs.20,17,193/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year. And the balance of his savings bank account(s) is also reduced for Rs.5,09,405/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement at the time of entering into Judicial Service which had already been seen by Hon'ble Mr. Justice Ritu Raj Awasthi, the then Administrative Judge, Deoria. And for the financial years 2009-10 to 2014-15, offline office note has been submitted before Hon'ble Mr. Justice Karunesh Singh Pawar, Administrative Judge, Sitapur Judgeship for His Lordship's kind perusal and orders, placed in the misc. file of the officer. Office note regarding property statements of the financial year 2015-17 has been submitted online before Hon'ble Mr. Justice Karunesh Singh Pawar, Administrative Judge, Sitapur Judgeship for His Lordship's kind perusal and orders on e-service ID 3966.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 firstly vide online dated 11.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "he could not send the required particulars of property in time because non availability of details of immovable properties due to unavoidable circumstances and limited functioning of the court due to corona pandemic. He sincerely apologize for the delay in this regard", mentioned in remark column of movable proforma.

May, therefore, if approved, property statements of the financial year 2017-18 & 2018-19 of Sri Ram Mani Pathak, Additional Principal Judge, Family Court, Sitapur be laid before Hon'ble Mr. Justice Karunesh Singh Pawar, Administrative Judge, Sitapur Judgeship for His Lordship's kind perusal and orders?
