In this regard, officer has stated that he could not submit his property statement due to unprecedented outbreak of Covid-19. He sincerely apologies and humbly pray that delay, if any, may kindly be condoned. He has, therefore, humbly requested to kindly place the property statement before Hon'ble Court and he will be highly grateful.
