May kindly see the property statement online received from Sri Bhartendu Prakash Gupta, Judge Small Causes Court, Agra regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial years 2016-18 (2016-17 & 2017-18)**, Gross income from salary is Rs.24,01,169/- and total deductions/savings/ investment against NPS, GIS, PPF, Income Tax, RD, Insurances and the balance of his savings bank account(s) is also enhanced by Rs.1,87,128/- in this financial year from previous year's balance, total of which is Rs.7,78,569/-. Thus a sum of Rs.16,22,600/- was therefore available with him to meet out the household expenditure of his family consist of four members in the financial years 2016-18 (2016-17 & 2017-18).

In this connection, it is submitted that the Officer has already submitted his property statement up to the financial year 2015-16, which had already been seen by Hon'ble Mr. Justice Shashi Kant Gupta, the then Administrative Judge, Ghaziabad in the Misc. file of the Officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial year 2016-18 (2016-17 & 2017-18) vide online dated 08.12.2021. As such, there is delay in submitting the same. In this regard, officer has stated that he could not submit his property statement due to unprecedented outbreak of Covid-19. He sincerely apologies and humbly pray that delay, if any, may kindly be condoned. He has, therefore, humbly requested to kindly place the property statement before Hon'ble Court and he will be highly grateful.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Bhartendu Prakash Gupta, Judge Small Causes Court, Agra be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra for His Lordship's kind perusal and orders?
