May kindly see the property statement online received from Sri Mahendra Nath, Presiding Officer, Motor Accident Claims Tribunal, Raebareli regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary and other sources is Rs.46,46,712/- and total deductions/savings/ investment against GPF, GIS, PPF, Income Tax, Insurances and the balance of his savings bank account(s) is also enhanced by Rs.10,95,497/- in this financial year from previous year's balance, total of which is Rs.35,75,198/-. Thus a sum of Rs.10,71,514/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2018-20 (2018-19 & 2019-20).

It is pertinent mention here that officer's wife (House rent) annual income was Rs.61,200/- during the financial years 2018-19 and 2019-20.

In this connection, it is submitted that the Officer has already submitted his property statement up to the financial year 2017-18, which had been seen by Hon'ble Mr. Justice Anil Kumar, the then, Administrative Judge, Mathura in the Misc. file of the Officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 06.12.2021. As such, there is delay in submitting the same. In this regard, officer has stated that due to covid and annual transfer, he could not submit his property statement. Officer has apologized for delay.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Mahendra Nath, Presiding Officer, Motor Accident Claims Tribunal, Raebareli be laid before Hon'ble Mr. Justice Samit Gopal, Administrative Judge, Raebareli for His Lordship's kind perusal and orders?
