May kindly see the property statement submitted online received from Sri Atul Chaudhary, Chief Judicial Magistrate, Bareilly regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2013-15 (2013-14 & 2014-15) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2013-15 (2013-14 & 2014-15) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below:-

In the financial year 2013-15 (2013-14 & 2014-15), his total income from salary and other sources is Rs. 16,76,996/- and deductions/savings/investments against NPS, GIS, Income Tax, Insurances (LIC & Max New York Life), repayment of Home Loan, PPF (2 A/Cs), Mutual Fund, RD and the balance of his Saving bank A/c(s) is enhanced for Rs. 7,108/- this financial year from previous year's balance, total of which comes to Rs. 10,29,468/-. Thus, a sum of Rs. 6,47,528/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements offline for the financial year 2012-13 which has already been seen by Hon'ble Mr. Justice Ashok Pal Singh, the then Administrative Judge, Basti Judgeship on 11.11.2014 in the misc. file of the officer in offline mode.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2013-15 (2013-14 & 2014-15) in its next financial year i.e., 2015-16 upto 31st March 2016. He has submitted movable and immovable property statements for the financial years 2013-15 (2013-14 & 2014-15) firstly vide his application dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer and the officer has stated that due to transfer in year April, 2015 and also because of birth of his first son, he could not send the property statement timely. This mistake is not because of any bad intension. He is regretful for this act and stated that this will not be repeated in future.

May, therefore, if approved, property statements for the financial years 2013-15 (2013-14 & 2014-15) of Sri Atul Chaudhary, Chief Judicial Magistrate, Bareilly, be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
