

## **Registrar(J)(Budget)**

May kindly see the online reply dated 03.02.2023 received from Sushri Saba Fatima, Civil Judge (Junior Div.), Barabanki, in compliance of order of Hon'ble Mr. Justice Samit Gopal, the then Administrative Judge, Kaushambi, in the matter of property statements held at the time of entering i.e., of joining into U.P. Judicial Service, communicated to the officer.

In this connection, it is submitted that the officer had submitted her movable & immovable property statements held at the time of entering i.e., of joining into U.P. Judicial Service, which was put up before Hon'ble the Administrative Judge, Kaushambi through detailed office note dated 24.05.2022, on which His Lordship has been pleased to pass the following order dated 21.12.2022:

**"There is a delay in filing of the property statement from the date of joining itself.**

**Let the delay be explained."**

The order of the Court had been communicated to the officer concerned on 13.01.2023.

In reply/compliance of the Hon'ble Court's Order, the officer concerned has stated in her letter as attachment dated 02.02.2023, that:

*"It is most humbly submitted in your goodself that the information regarding the property statement at the time of joining, has been sent to the Hon'ble Court, vide application I.D. No. 3862, on date 16.12.2021.*

*It is further intimated in your goodself with regard to delayed filing of desired information that after joining, due to Institutional Training and thereafter pandemic Covid-19 period started and thereafter some time/period lapsed to collect the documents/statements from the Banks, due to which, I was not able to submit my property statement timely.*

*Inconvenience caused in your goodself is highly regretted. I tender my unconditional apology for the same."*

It is further submitted that as per policy/Court's Circular letter, the officer has to submit property statement held at the time of joining the Uttar Pradesh Judicial Services on or just after the joining into the Uttar Pradesh Judicial Services. She has submitted the aforesaid property statement through her online request dated 08.12.2021. Her joining date is 16.12.2019. As such, there is delay in submitting aforesaid property statement from the part of the officer. In this regard, officer has given the reason for delay and compliance the Hon'ble Court's order.

May therefore, if approved, movable & immovable property statement held at the time of entering i.e., of joining into U.P. Judicial service alongwith the reply/ compliance of Hon'ble Court's order, as desired by the Court in the matter, furnished by Sushri Saba Fatima, Civil Judge (Junior Div.), Barabanki, be laid before Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Barabanki Judgeship for His Lordship's kind perusal and further orders?
