In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary is Rs.32,85,042/and total deductions/savings/ investment against NPS, GIS, PPF, Income Tax, NSC, SBI term deposit, Mutual Funds and Insurances is Rs.17,83,476/-. Thus a sum of Rs.15,36,538/-( Rs.15,01,566/- from salary and Rs.34,972 from saving bank account) was therefore available with him to meet out the household expenditure of his family consist of four members in the financial years 2018-20 (2018-19 & 2019-20) and the balance of his savings account is also decreased for Rs.34,972/- this financial year from previous year balance.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial years 2016-18 (2016-17 & 2017-18) online against case id- P00017312021(old case id-3850) and same has been processed before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 08.12.2021. As such, there is delay in submitting the same. In this regard, officer has stated that he could not submit his property statement due to unprecedented outbreak of Covid-19. He sincerely apologies and humbly pray that delay, if any, may kindly be condoned. He has, therefore, humbly requested to kindly place the property statement before Hon'ble Court and he will be highly grateful.
