May kindly see the property statement received online from Sri Prakash Nath Srivastava, Presiding Officer, Motor Accident Claims Tribunal, Bhadohi at Gyanpur, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial year 2018-20 (2018-19 & 2019-20), the Gross salary is Rs. 50,12,008/- and total deductions/savings/ investment against GPF, GIS, Car loan repayment, Income Tax, Insurances is 28,35,763/- and the balance of his savings bank account(s) is also reduced by Rs.1,35,684/- in this financial year from previous year's balance. Thus, a sum of Rs. 23,11,929/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2018-20 (2018-19 & 2019-20).

It is pertinent to mention here that the officer's wife income was Rs.3,00,000/- annually in the financial year 2018-20 (2018-19 & 2019-20).

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2016-18 (2016-17 & 2017-18) offline in the misc file of the officer and the same has been seen by Hon'ble Mr. Justice Ram Manohar Narayan Mishra, Administrative Judge, Auraiya Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 09.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, the officer has not given reason for delay.

May, therefore, if approved, property statements for the financial year 2018-20 (2018-19 & 2019-20) of Sri Prakash Nath Srivastava, Presiding Officer, Motor Accident Claims Tribunal, Bhadohi at Gyanpur, be laid before Hon'ble Mr. Justice Mohd. Azhar Husain Idrisi, Administrative Judge, Bhadohi at Gyanpur Judgeship for His Lordship's kind perusal and orders?
