

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Sri Randheer Singh, Chairman, Commercial Tax Tribunal, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial year 2018-2020 (2018-19 & 2019-20)**, the Gross income is Rs.89,18,467/- (Rs.64,83,726/- from Salary, Rs.12,14,400/- from House Rent, Rs.66,000/- from SB Interest, Rs.7,05,224/- from Mutual Funds redemption, Rs.2,70,627/- from SBI Life Maturity & Rs.1,78,490/- from ICICI Pension Maturity) and total deductions/savings/investment against GIS, GPF, SIPs, Mutual Funds, Loan repayments, Flat Booking, Insurances and Income Tax is Rs.43,37,058/- and the balance of his savings bank account(s) is also increased by Rs.11,89,942/- in this financial year from previous year's balance, total of which is Rs.55,27,000/-. Thus, a sum of Rs.33,91,467/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2018-2020 (2018-19 & 2019-20).

It is pertinent to mention here that his wife have annual income of Rs.60,000/- from Boutique & Handicraft and also his son have annual income of Rs. 1 Lac approx. from Consultancy & Computer Work.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2016-2018 (2016-17 & 2017-18) online against Case Id : P00065332022 and the same has been processed before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 07.12.2021. As such, there is delay in submitting the same for which the officer has not given any reason for delay.

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Sri Randheer Singh, Chairman, Commercial Tax Tribunal, Lucknow, be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
