May kindly see the property statement submitted online received from Sri Anurag Sharma, Additional District & Sessions Judge (F.T.C.), Firozabad, regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2013-15 (2013-14 & 2014-15) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2013-15 (2013-14 & 2014-15) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2013-15 (2013-14 & 2014-15), his Total income from salary and other sources is Rs. 15,21,538/- and total deductions/savings/investments against NPS, GIS, Income Tax, Insurance policy and FD is Rs. 6,49,225/-. Thus a sum of Rs. 8,72,313/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs. 77,526/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statements offline for the financial year 2012-13 which has already been seen offline by Hon'ble Mr. Justice Rajiv Sharma, the then Administrative Judge, Bulandshahr Judgeship on 27.01.2015 in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2013-15 (2013-14 & 2014-15) in its next financial year i.e., 2015-16 upto 31st March 2016. He has submitted movable and immovable property statements for the financial years 2013-15 (2013-14 & 2014-15) firstly vide his application dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer and the officer has stated that the property statement could not be send on time because of work load and mistake. He felt sorry for not sending property statement on time and humbly requested that the Hon'ble Court may be pleased to forgive him regarding this mistake.

May, therefore, if approved, property statements for the financial years 2013-15 (2013-14 & 2014-15) of Sri Anurag Sharma, Additional District & Sessions Judge (F.T.C.), Firozabad, be laid before Hon'ble Mr. Justice Jasprit Singh, Administrative Judge, Firozabad Judgeship for His Lordship's kind perusal and orders?
