

## **Registrar(J)(Budget)**

May kindly see the property statement online received from Sri Manoj Pandey, Joint Registrar (J)(Stationary), High Court Lucknow Bench, Lucknow regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial years 2017-19 (2017-18 & 2018-19)**, his gross income from salary is Rs.30,73,493/- and total deductions/Savings/investments against Savings in Bank account, NPS, GIS, Income Tax, PPF and Mutual Funds (SIP) are Rs.9,88,834/-. The balance of Rs.61,521/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.20,84,659/- was therefore available with him to meet out the household expenditure of his family consisting three members in the financial years 2017-19 (2017-18 & 2018-19).

It is pertinent mention here that officer wife (Dentist) annual income was Rs.3,40,000/- for the F.Y. 2017-18 and Rs.3,25,000/- for F.Y. 2018-19 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2009-10 to 2016-17 offline, which had already been seen by Hon'ble Mr. Justice Rakesh Srivastava, the then Administrative Judge, Jhansi Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide online dated 08.12.2021. As such, there is delay in submitting the same. In this regard, officer verbatim: ".... It is most humbly submitted that due to unavoidable personal problems applicant could not furnish the property-statement for the financial year from 2017-18 and 2018-19. The applicant is highly apologetic and prays that in future the statement will be furnished well within time."

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Manoj Pandey, Joint Registrar (J)(Stationary), High Court Lucknow Bench, Lucknow be laid before Hon'ble The Chief Justice, High Court, Allahabad for His Lordship's kind perusal and orders?
