May kindly see the property statement received online from Smt. Kalpana Yadav, Addl. Civil Judge (Sr.Div.)/ACJM., Jhansi regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2018-2020 (2018-19 & 2019-20), the Gross income is Rs.14,95,589/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Loan repayments and Income Tax are Rs.5,61,653/- and the balance of her savings bank account is also increased by Rs.97,027/- in this financial year from previous year's balance, total of which is Rs.6,58,680/-. Thus, a sum of Rs.8,36,909/- was therefore available with her to meet out the household expenditure of her family consisting two members of the financial year 2018-2020 (2018-19 & 2019-20).

It is also pertinent to mention here that the her husband is a Judicial Officer having annual income of Rs.10,62,066/- in the financial year 2019-20.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements held at the time of joining into U.P. Judicial Service online against Case Id: P00008272021 (Old Case Id: 2900) and the same has been processed before Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Jhansi Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 10.12.2021. As such, there is delay in submitting the same for which the officer has stated in the remark column, that due to correction of car registration papers by RTO, Allahabad and Loan papers at her home district the property statement of the above financial year could not be submitted in time for which she seeks apology.

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Smt. Kalpana Yadav, Addl.
