In the financial year 2019-21 (2019-20 & 2020-21), his Total income from salary is Rs. 30,68,782/and total deductions/savings/investments against NPS, GIS, Income Tax, PPF, Insurances (LIC and SBI General Health Insurance), repayment of Car Loan and the balance of his Saving bank A/c(s) is enhanced for Rs. 4,18,210/- this financial year from previous year's balance, total of which is Rs. 15,02,339/-. Thus a sum of Rs. 15,66,443/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent mention here that officer's wife (U.P. Judicial officer) having annual income was Rs.14,25,871/- for the financial year 2019-20 and Rs.12,08,021/- for the financial year 2020-21.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial year 2017-19 which has already been approved on 02.02.2021 by Hon'ble Mr. Justice Om Prakash VII, the then Administrative Judge, Varanasi Judgeship on e-service old case Id no. 746.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto 31st March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide his application dated 10.12.2021. As such, there is no delay in submitting the same.
