In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary is Rs.19,86,136/- and total deductions/savings/ investment against GIS, Income Tax, PPF and LIC Policy are Rs.5,76,204/-. Thus, a sum of Rs.14,09,932/- was therefore available with him to meet out the household expenditure of his family consisting two members for both the financial years. And the balance of his savings bank account(s) is also reduced by Rs.1,25,916/- in this financial year from previous year's balance. It is pertinent to mention here that his wife is a private teacher whose income is Rs.10000/- monthly.

In this connection, it is submitted that the Officer has already submitted his property statements of the financial years 2016-18 online against Case Id- P00011032021 respectively, same has been processed before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 08.12.2021. As such, there is delay in submitting the same. In this regard, officer has stated "that the undersigned was required to submit his property details for the financial year ending 2018-19 and 2019-20 till march, 2021 to the Hon'ble Court. However, due to covid-19 pandemic and the lockdown situation, the undersigned was unable to submit property statement as all property details were kept at Kannauj at the permanent address of the undersigned, therefore it took sometime to collect the details which resulted in causing delay of the submission of the details. The statement of the property for the financial year ending 2018-19 and 2019-20 are being submitted herewith a humble request to condone the delay caused. The undersigned would be very careful in future to submit the details within time. The undersigned shall be highly obliged" (mentioning in enclosed letter).
