May kindly see the property statement submitted online dated 09.12.2021 received from Sri Krishna Kumar Singh-II, Additional District & Sessions Judge, Baghpat regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2012-14 (2012-13 & 2013-14) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2012-14 (2012-13 & 2013-14) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial years 2012-14 (2012-13 & 2013-14), income from salary is Rs.18,80,775/-(income from salary Rs.16,85,633/-, income from agriculture Rs.1,90,000/- and income from Interest Rs.5,142/-), and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF and the balance of his savings bank account(s) is also enhanced for Rs.2,56,951/- this financial year from previous year's balance, total of which is Rs.4,34,977/-. Thus, a sum of Rs.14,45,790/- was therefore available with him to meet out the household expenditure of his family consisting of four members for both the financial years 2012-14 (2012-13 & 2013-14).

It is pertinent to mention here that wife of the officer Smt. Chanchal Singh (A.D.J.), annual income for the F.Y. 2012-13 is Rs.7,08,655/- lacs & for 2013-14 is Rs.4,10,993/- lacs.

In this connection it is submitted that, he has submitted his property statement upto the financial year 2010-12, which has already been processed before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Baghpat on old case Id no-3868.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2012-14 (2012-13 & 2013-14) in its next financial year i.e., 2014-15 upto March 2015. He has submitted movable and immovable property statements of the financial year 2012-13 & 2013-14 vide online dated 09.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has stated that he was promoted and transfer from Firozabad to Bijnor therefore, he could not prepare his statement in due time.

May, therefore, if approved, property statements for the financial year 2012-14 (2012-13 & 2013-14) of Sri Krishna Kumar Singh-II, Additional District & Sessions Judge, Baghpat be laid before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Baghpat Judgeship for His Lordship's kind perusal and orders?
