May kindly see the property statement submitted online received from Sri Atul Chaudhary, Chief Judicial Magistrate, Bareilly, regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below:-

In the financial year 2017-19 (2017-18 & 2018-19), his total income from salary is Rs. 36,16,765/- and deductions/savings/investments against NPS, GIS, Income Tax, Insurances (LICs), repayment of Home Loan, PPF (2 A/Cs), Mutual Fund and the balance of his Saving bank A/c(s) is enhanced for Rs. 9,87,827/- this financial year from previous year's balance, total of which comes to Rs. 26,87,749/-. Thus, a sum of Rs. 9,29,016/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial years 2015-17 (2015-16 & 2016-17) which is also processed online and laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Bareilly, Judgeship for kind perusal and order on another e-service Id no. 3907.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto 31st March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) firstly vide his application dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer and the officer has stated that due to transfer in the year 2019 in April, he could not send the property statement timely, the mistake is bonafide. He is very regretful for not sending the property statement in time and assures that this act will not be repeated in future. He further requested to accept his property statement.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Atul Chaudhary, Chief Judicial Magistrate, Bareilly, be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Bareilly for His Lordship's kind perusal and orders?
