May kindly see the online property statement submitted by Sri Atul Chaudhary, Chief Judicial Magistrate, Bareilly regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below:-

In the financial year 2019-21 (2019-20 & 2020-21), his total income from salary is Rs. 38,38,200/- and deductions/savings/investments against NPS, GIS, Income Tax, Insurances (LICs), repayment of Home Loan, PPF (2 A/Cs) and Mutual Fund, total of which comes to Rs. 18,12,744/-. Thus, a sum of Rs. 20,25,456/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years. The balance of his Saving bank A/c(s) is also reduced to Rs. 9,191/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statements online upto the financial years 2017-19 (2017-18 & 2018-19) which has already been "Seen/ Keep on record" by Hon'ble Mr. Justice Attau Rahman Masoodi, the then Hon'ble Administrative Judge, Bareilly Judgeship on 28.03.2022 in e-service Id no. 3909.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto 31st March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide his E-service ID no. 3914 dated 06.12.2021, however, forwarded by the District Judge on 01.04.2022. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, the property statement for the financial years 2019-21 (2019-20 & 2020-21) of Sri Atul Chaudhary, Chief Judicial Magistrate, Bareilly be laid before Hon'ble Mr. Justice Ashwani Kumar Mishra, Administrative Judge, Bareilly for His Lordship's kind perusal and orders?
