May kindly see the property statement submitted online dated 09.12.2021 received from Sri Krishna Kumar Singh-II, Additional District & Sessions Judge, Baghpat regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2014-15 (2014-15 & 2015-16) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2014-15 (2014-15 & 2015-16) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial years 2014-15 (2014-15 & 2015-16), income from salary is Rs.23,73,321/-(income from salary Rs.21,37,772/-, income from agriculture Rs.2,30,000/- and income from Interest Rs.5,549/-), and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF and the balance of his savings bank account(s) is also enhanced for Rs.1,69,661/- this financial year from previous year's balance, total of which is Rs.5,83,633/-. Thus, a sum of Rs.17,89,688/- was therefore available with him to meet out the household expenditure of his family consisting of four members for both the financial years 2014-15 (2014-15 & 2015-16).

It is pertinent to mention here that wife of the officer Smt. Chanchal Singh (A.D.J.), annual income for the F.Y. 2014-15 is Rs.13,13,167/- lacs & for 2015-16 is Rs.11,21,186/- lacs.

In this connection it is submitted that, he has submitted his property statement upto the financial year 2012-14, which has already been processed before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Baghpat on old case Id no-3908.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2014-15 (2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto March 2017. He has submitted movable and immovable property statements of the financial year 2014-15 (2014-15 & 2015-16) vide online dated 09.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has stated that he was preparing for LCE examme and his father was ill and admitted in aiims Delhi and was busy their treatment and was also transfer Bijnor to Gorakhpur so therefore, he could not prepare his statement in due time.

May, therefore, if approved, property statements for the financial year 2014-15 (2014-15 & 2015-16) of Sri Krishna Kumar Singh-II, Additional District & Sessions Judge, Baghpat be laid before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Baghpat Judgship for His Lordship's kind perusal and orders?
