May kindly see the property statement online received from Sri. Rajat Verma, Addidtional District & Sessions Judge, Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20(2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20(2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20(2018-19 & 2019-20), Gross income from salary, allowances, arrears and Bank interest is Rs.42,67,696/- and total deductions/ repayment/ savings/ investment against NPS, Income Tax, GIS, PPF, LIC Policy, Home Loan Emi, Car Loan Emi and the balance of his savings bank account(s) is enhanced by Rs.6,65,673/- this financial year from previous year's balance, total of which is Rs.30,44,654/-. Thus, a sum of Rs.12,23,042/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

It is pertinent to mention here that his wife is working as an advocate having annual income Rs.1,90,000/-.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2016-18 online against Case Id- P00018522021 and same has been moved before Hon'ble Mr. Justice Suneet Kumar, Administrative Judge, Varanasi Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20(2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20(2018-19 & 2019-20) vide online dated 09.12.2021. As such, there is delay in submitting the same. In this regard officer has stated that he had forwarded his property statement for the year 2014-2015 and 2015-2016 in the year 2017. However, it was returned back to him by the Hon'ble Court as some fugures were not mentioned clearly in the same. Thereafter he could not forward the same in time for which he is very humbly apologize, he assure that in future he will keep submitting the statement in time.

May, therefore, if approved, property statements for the financial years 2018-20(2018-19 & 2019-20) of Sri. Rajat Verma, Addidtional District & Sessions Judge, Varanasi be laid before Hon'ble Mr. Justice Suneet Kumar, Administrative Judge, Varanasi for His Lordship's kind perusal and orders?
