May kindly see the online reply dated 19.09.2023 received from Smt. Mona Singh, Addl. Civil Judge (Sr.Div.)/ACJM, Lakhimpur Kheri, in compliance of order of Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri, in the matter of property statements held at the time of entering i.e., of joining into U.P. Judicial Service, communicated to the officer.

In this connection, it is submitted that the officer had submitted her movable & immovable property statements held at the time of entering i.e., of joining into U.P. Judicial Service, which was put up before Hon'ble the Administrative Judge, Lakhimpur Kheri through detailed office note dated 23.05.2023, on which His Lordship has been pleased to pass the following order dated 20.07.2023:

"This property statement has been submitted by the officer concerned indicating the movable properties held at the time of joining the service. Her joining is indicated as 08.02.2017 and the statement was to be submitted just after entering into service. The statement is being placed before me in July 2023. In the remark column, it has been indicated by the officer concerned that the property statement could not be submitted by her on time due to health issues. Since 2017, substantial period has lapsed.

Call for a report from the officer concerned as to whether she has submitted her property statements for the subsequent blocks/years within time and if not, the reasons thereof."

The order of the Court had been communicated to the officer concerned on 20.07.2023.

In reply/compliance of the Hon'ble Court's Order, the officer concerned has stated that (in her verbatim):

"With humble request, it is to submit that the property statement for the financial year 2018-2019 in offline mode was sent by me, through the then Respected District Judge with letter no . 2656/Mirzapur dated 18-11-2019, to the Hon'ble High Court. In the objection, it was directed to be sent through e-service portal, after which I submitted the property statement for financial year 2017-2019 and 2019-2021 through e-service portal in December 2021. I had no intention of submitting so late. The main reason for being late was the lack of technical knowledge about use of the portal and it took me some time to understand. Currently, the previously submitted property statement has been updated by correcting the block / year as per the direction of the Hon'ble High Court.

I apologize for this delay and in future the property statement will be submitted with full sincerity at the end of the financial year."

In reference of the above explanation/report from the officer, it is submitted that the officer concerned has submitted her property statement along with apology for late submission, held at the time of joining into U.P. Judicial Service and for the financial year 2018-19 offline vide letter no. 2656/I/Mirzapur/Dated 18.11.2019. After perusal of the statements, accordingly, Objections has been raised vide Court's letter no. 198/IV-4377/Admin (A)/ Dated 06.1.2020 (offline) and the officer was asked to submit the property statement held at the time of joining into U.P. Judicial Service and for the financial year 2017-18 & 2018-19 along with reason for delay and other required details, online through e-Services Portal. In compliance of the Court's letter, she has submitted property statement held at the time of joining into U.P. Judicial Service, for block financial year 2017-19 (later corrected for 2016-2018), 2019-21 (later corrected for 2018-20) vide online on eServicesJO portal against Case Id: P00018022021 (Old Case Id : 3922), P00021202021 (Old Case Id : 4247), P00023862021 (Old Case Id : 4517) respectively all three on 09.12.2021. The property statement for the financial year 2020-2022 against Case Id: P00006992023 has also submitted by the officer on 20.09.2023.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement held at the time of joining into judicial service just after joining into U. P. Judicial Service. She has firstly submitted the property statement held at the time of joining into U.P. Judicial Service offline on 18.11.2019. Her joining date is 08.02.2017. As such, there is delay in submitting aforesaid

property statement from the part of the officer. In this regard, officer has given the reason for delay and compliance the Hon'ble Court's order. Property statements of subsequent blocks of two years after correction i.e for 2016-18, 2018-20 and also for 2020-22 have also been processed and submitted in separate case IDs.

May therefore, if approved, movable & immovable property statement held at the time of entering i.e., of joining into U.P. Judicial service alongwith the reply/ compliance of Hon'ble Court's order, as desired by the Court in the matter, furnished by Smt. Mona Singh, Addl. Civil Judge (Sr.Div.)/ACJM, Lakhimpur Kheri, be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri Judgeship for His Lordship's kind perusal and further orders?
