May kindly see the property statement online received from Smt. Pratibha Saxena-II, Additional District & Sessions Judge, Bareilly regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2010-12 (2010-11 & 2011-12) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2010-12 (2010-11 & 2011-12) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2010-12 (2010-11 & 2011-12), her gross income from salary is Rs.20,06,394/- and total deductions/Savings/investments against Deposits in saving bank account, GIS, Income Tax, Repayment of personal loan & car loan alongwith down-payment, NSC and Insurances are Rs.9,39,477/-. The balance of Rs.93,746/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.10,66,917/- was therefore available with her to meet out the household expenditure of her family consisting three members in the financial years 2010-12 (2010-11 & 2011-12) (annexure attached).

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2008-10 (2008-09 & 2009-10) offline (in Misc. file of the officer) and same has been processed before Hon'ble Mr. Justice Ajeet Kumar, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2010-12 (2010-11 & 2011-12) in its next financial year i.e., 2012-13 upto March 2013. She had submitted movable and immovable property statements for the financial years 2010-12 (2010-11 & 2011-12) vide online dated 09.12.2021 on eServicesJo portal. As such, there is delay in submitting the same. In this regard, officer verbatim: "..... delay caused in getting information from concern Bank authorities, Post officer etc. which was beyond the control of undersigned and for that delay the undersigned seek apology from the Hon'ble Court. Revised movable and immovable property-statement for the financial years 2010-11 and 2011-12 are being submitted hereby for kind perusal of the Hon'ble Court."

May, therefore, if approved, property statements for the financial years 2010-12 (2010-11 & 2011-12) of Smt. Pratibha Saxena-II, Additional District & Sessions Judge, Bareilly be laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
