May kindly see the property statement online received from Smt. Ekta Singh-I, Judge, Special Court, CBI Court No. 6, Lucknow regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2017-19 (2017-18 and 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 and 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2017-19 (2017-18 and 2018-19), her gross income from salary is Rs.26,45,874/- and total deductions/Savings/investments against Deposits in Saving Bank Account, NPS, GIS, Income Tax, Repayment of Home Loan, PPF and Insurances are Rs.12,23,080/-. The balance of Rs.1,63,992/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.14,22,794/- was therefore available with her to meet out the household expenditure of her family consisting four members in the financial years 2017-19 (2017-18 and 2018-19)

In this connection, it is submitted that the Officer has already submitted her property statement held at the time of Joining in to U.P. Judicial Service along-with for the financial years 2009-11, 2011-13, 2013-15 and 2015-17 offline in the misc. file of the officer and same has been processed before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders. .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2017-19 (2017-18 and 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She had submitted movable and immovable property statements for the financial years 2017-19 (2017-18 and 2018-19) vide online dated 11.12.2021 on eServicesJo portal. As such, there is delay in submitting the same. In this regard, officer verbatim: "Due to excessive work pressure, health issues, Family disturbance, loss of various records failed to submit property statement within time. I beg for unconditional apology to Hon'ble Court."

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 and 2018-19) of Smt. Ekta Singh-I, Judge, Special Court, CBI Court No. 6, Lucknow be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
