

## **Registrar(J)(Budget)**

May kindly see the property statement online received from Sri Shakti Putra Tomar, Special Judge (SC/ST, Pev. of Atroci Act), Jhansi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2019-21 (2019-20 & 2020-21), Gross income from salary and arrears is Rs.40,97,724/- and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF, Insurances and Loan, total of which is Rs.21,39,988/-. Thus, a sum of Rs.19,57,736/- was available with him to meet out the household expenditure of his family consisting of three members in both of the financial years. And the balance of his savings bank account(s) is reduced by Rs.6,09,969/- this financial year from previous year's balance.

It is pertinent to mention here that his wife is advocate, having annual income of Rs.6,36,000/- & Rs.4,63,000/- for the financial year 2019-20 & 2020-21 respectively, as mentioned by the officer.

In this connection, it is submitted that the officer has already submitted his property statements upto the financial years 2018-19 online against Case Id : P00001402019 and the same has been seen online by Hon'ble Mr. Justice Pankaj Naqvi, the then Administrative Judge, Budaun Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) vide online dated 10.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Shakti Putra Tomar, Special Judge (SC/ST, Pev. of Atroci Act), Jhansi be laid before Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Jhansi Judgeship for His Lordship's kind perusal and orders?
