May kindly see the property statements online received from Smt. Chanchal, Additional Principal Judge, Family Court, Firozabad regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2014-16(2014-15 & 2015-16) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2014-16(2014-15 & 2015-16) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

In the financial years 2014-16(2014-15 & 2015-16), Total income is Rs.24,40,225/- (income from salary Rs.24,34,353/- and income from S.B. a/c Interests Rs.5,872/-) and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF, LIC Insurance, total of which is Rs.4,01,931. Thus, a sum of Rs.20,38,294/- was therefore available with her to meet out the household expenditure of her family consisting of four members for both the financial years. And the balance of her savings bank account(s) is also decreased for Rs.1,51,843/- this financial year from previous year's balance.

It is pertinent to mention here that her husband Mr. Krishna Kumar Singh is ADJ and his annual income for the F.Y. 2014-15 Rs.8,29,374/- and for the F.Y. 2015-16 Rs.13,08,398/- .

In this connection, it is submitted that the Officer has already submitted her property statements of the financial year 2012-14 online and same has been processed before the Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Firozabad on old case Id no-3958.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2014-16(2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto March 2017. She has submitted movable and immovable property statements of the financial years 2014-16(2014-15 & 2015-16) vide online dated 09.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has mentioned that she was preparing for LCE exam and her father was admitted in aiims Delhi and was busy in their treatment and was also transferred Bijnor to Gorakhpur, therefore, she could not prepare her statement in due time and she humbly requested to accept her delay statement.

May, therefore, if approved, property statements for the financial years 2014-16(2014-15 & 2015-16) of Smt. Chanchal, Additional Principal Judge, Family Court, Firozabad, be laid before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Firozabad Judgeship for His Lordship's kind perusal and orders?
