May kindly see the property statement received from Sri Ashish Kumar Rai, Chief Judicial Magistrate, Basti regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2013-15 (2013-14 & 2014-15) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2013-15 (2013-14 & 2014-15) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial year 2013-15 (2013-14 & 2014-15), gross income is Rs.10,29,878/- (income from salary Rs.10,28,118/- and income from P.M. relief fund Rs.1760/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against CPF, GIS, Income Tax, LIC and the balance of his savings bank account(s) is enhanced for Rs.1,89,100/- this financial year from previous year's balance, total of which is Rs.3,19,158/-. Thus, a sum of Rs.7,10,720/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years.

It is pertinent to mention here that his father Sri Santosh Kumar Rai (Profession-farmer) Annual Income about Rs.2 Lacs approx.

In this connection, it is submitted that the officer has already submitted his property statement at the time of entering into judicial service which had already been approved by Hon'ble Mr. Justice Pankaj Bhatia, the then Administrative Judge, Basti on old case Id no-3957.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2013-15 (2013-14 & 2014-15) in its next financial year i.e., 2015-16 upto March 2016. He has submitted movable and immovable property statements of the financial years 2013-14 & 2014-15 vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has stated that due to health reasons of his parents, who are in their old age, Officer's father was suffering from chronic heart dieseas, kidney dieseas, chest dieseas etc. and was bedridden due to severe paralytic attack and he has died on 30th of May,2021. He further assured to be careful and punctual in future.

May, therefore, if approved, property statements of the financial year 2013-15 (2013-14 & 2014-15) of Sri Ashish Kumar Rai, Chief Judicial Magistrate, Basti be laid before Hon'ble Mr. Justice Karunesh Singh Pawar, Administrative Judge, Basti Judgeship for His Lordship's kind perusal and orders?
