May kindly see the property statements online received from Smt. Chanchal, Additional Principal Judge, Family Court, Firozabad regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2018-20(2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

In the financial years 2018-20(2018-19 & 2019-20), Total income is Rs.38,77,389/- (income from salary Rs.36,37,256/- and income from S.B. a/c Interests Rs.2,40,133/-) and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, LIC Insurance and the balance of her savings bank account(s) is also increased for Rs.11,39,887/- this financial year from previous year's balance, total of which is Rs.18,89,658. Thus, a sum of Rs.19,87,731/- was therefore available with her to meet out the household expenditure of her family consisting of four members for both the financial years.

It is pertinent to mention here that her husband Mr. Krishna Kumar Singh is ADJ and his annual income for the F.Y. 2018-19 Rs.17,92,789/- and for the F.Y. 2019-20 Rs.17,56,239/- .

In this connection, it is submitted that the Officer has already submitted her property statements of the financial year 2016-18 online and the same has been processed before the Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Firozabad on old case Id no-3972.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20(2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-20(2018-19 & 2019-20) vide online dated 09.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has mentioned that due to pandemic situation she could not prepare her statement in due time therefore, she humbly requested to accept her delay statement.

May, therefore, if approved, property statements for the financial years 2018-20(2018-19 & 2019-20) of Smt. Chanchal, Additional Principal Judge, Family Court, Firozabad, be laid before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Firozabad Judgeship for His Lordship's kind perusal and orders?
