May kindly see the property statement submitted online received from Sri Anurag Sharma, Additional District & Sessions Judge (F.T.C.), Firozabad, regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below:-

In the financial year 2019-21 (2019-20 & 2020-21), his Total income from salary is Rs. 41,29,759/- and deductions/savings/investments against GIS, Income Tax, Insurance policy, Car Loan and the balance of his Saving bank A/c(s) is enhanced for Rs. 58,12,00/- this financial year from previous year's balance, total of which comes to Rs. 16,03,149/-. Thus a sum of Rs. 25,26,610/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. The officer has stated that NPS amount has not been deducted during these years due to non-transfer of PRAN.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial years 2017-19 (2017-18 & 2018-19) which is also processed online and laid before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Firozabad Judgeship for kind perusal and order on another e-service Id no. 3894.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto 31st March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) firstly vide his application dated 10.12.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Anurag Sharma, Additional District & Sessions Judge (F.T.C.), Firozabad, be laid before Hon'ble Mr. Justice Jaspreet Singh, Administrative Judge, Firozabad Judgeship for His Lordship's kind perusal and orders?
