May kindly see the online letter 08.12.2021 received from Sushri Yogesh Shiva, Addl. Civil Judge( Junior Division), Anoopshahar-Bulandshahar, regarding submission of statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year 2018-20 her gross income from salary is Rs.14,20,986/-and total deductions /Savings/investments against, GIS ,PRAN &Income Tax is Rs.3,14,911/- (including enhancement of Rs.1,32,520/- in S.B.A/cs against the balance of previous year)- Thus a sum of Rs.11,06,075/- was therefore available with her to meet out the household expenditure of herself in the financial year 2018-20.

In this connection, it is submitted that the officer has submitted property statements online, at the time of entering U.P. Judicial Services i.e 28.09.2018, which is also being processed online on e-service id no. 2644 before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Bulandshahar for kind perusal and orders.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statement for financial year 2018-20(2018-19 & 2019-20) in its next financial year i.e 2020-21 upto 31st March 2021. She has submitted the aforesaid statement through her online e-service case id 4000 , dated 08.12.2021. As such, there is delay in submitting the aforesaid statement on the part of the officer. The reason for delay as stated by the officer is that , being a new joinee in judicial service ,she was under the wrong impression that property statement is submitted in the span of every three financial years. Therefore, she could not submit the statement on time. She shall not repeat this mistake in future. It is therefore most humbly requested that the Hon'ble court may kindly excuse the delay caused.

May, if approved, the statements of movable and immovable property for financial year 2018-20 of Sushri Yogesh Shiva, Addl. Civil Judge( Junior Division), Anoopshahar-Bulandshahar kindly be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Bulandshahar Judgeship for His Lordship's kind perusal and orders?
