May kindly see the property statement received from Sri Ashish Kumar Rai, Chief Judicial Magistrate, Basti regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

**In the financial year 2017-19 (2017-18 & 2018-19)**, Gross income from salary is Rs.21,79,595/- and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, Income Tax, LIC, PPF, Mutual Fund (SIP), SSA, repayment of car loan and the balance of his savings bank account(s) is enhanced for Rs.1,09,939/- this financial year from previous year's balance, total of which is Rs.9,87,715/-. Thus, a sum of Rs.11,91,880/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years.

It is pertinent to mention here that his wife Smt. Swati Rai, Profession- service (assistant manager, Union Bank Of India), Annual Income in F.Y. 2017-2018 Rs.5,10,159/- and in F.Y. 2018-2019- Rs.5,52,646/-

In this connection, it is submitted that the officer has already submitted his property statement of financial year 2015-17 which had already been processed before Hon'ble Mr. Justice Karunesh Singh Pawar, Administrative Judge, Basti on old case Id no-3986.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-19 (2017-18 & 2018-19) vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has stated that due to health reasons of his parents, who are in their old age, Officer's father was suffering from chronic heart diseases, kidney diseases, chest diseases etc. and was bedridden due to severe paralytic attack and he has died on 30th of May,2021. He further assured to be careful and punctual in future.

May, therefore, if approved, property statements of the financial year 2017-19 (2017-18 & 2018-19) of Sri Ashish Kumar Rai, Chief Judicial Magistrate, Basti be laid before Hon'ble Mr. Justice Karunesh Singh Pawar, Administrative Judge, Basti Judgship for His Lordship's kind perusal and orders?
