May kindly see the property statement submitted online received from Sri Sarvesh Kumar Mishra presently posted as Civil Judge (Senior Division), Ballia regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2017-19 (2017-18 & 2018-19), his Total income from salary and others sources is Rs. 18,30,820/- and total deductions/savings/investments against NPS, GIS, Income Tax, LIC and PPF is Rs. 10,71,509/- (including enhancement of Rs. 3,40,927/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs. 7,59,311/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that his father is a retired teacher and his average annual income is Rs. 5,00,000/- (income, pension and agriculture) and his wife Smt. Tapasya Tripathi is a Judicial Officer (JO code no. 2260) and her annual income from salary & arrear is Rs. 7,54,325/-.

In this connection, it is submitted that the officer has already submitted his property statements offline for the financial years 2015-17 (2015-16 & 2016-17) which is already processed offline and laid before Hon'ble Mr. Justice Prakash Padia, Administrative Judge, Ballia Judgeship in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2017-19 (2017-18 & 2018-19) in its next financial year i.e. 2019-20 upto 31st March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) firstly vide his application dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has requested that delay in Sending Property Statement was not occasioned deliberately but was the consequence of his bearing occupied in fulfilling the judicial work and family obligation and was bonafide for which apologise unconditionally. He urged to forgive the fault on his part and requested to accept the property statement.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Sarvesh Kumar Mishra, Civil Judge (Senior Division), Ballia be laid before Hon'ble Mr. Justice Prakash Padia, Administrative Judge, Ballia Judgeship for His Lordship's kind perusal and orders?
