

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Sri Satish Kumar Magan, Civil Judge (Senior Div.), Ayodhya regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial year 2018-2020 (2018-19 & 2019-20)**, the Gross income from salary is Rs.21,97,521/- and total deductions/savings/investment against GIS, NPS, LIC and Income Tax is Rs.5,68,472/- and the balance of his savings bank account(s) is also increased by Rs.15,05,553/- in this financial year from previous year's balance, total of which is Rs.20,74,025/-. Thus, a sum of Rs.1,23,496/- was therefore available with himself to meet out the household expenditure in the financial year 2018-2020 (2018-19 & 2019-20) which seems meagre amount.

In connection to the meagre amount i.e. Rs.1,23,496/-, objection has been raised online on dated 07.09.2022. In reply of the objection, the officer has stated in his online reply dated 16.01.2023, that:

*"I tender my unconditional apology for late submission of reply to the objection.*

*As contained in the objection about the detailed calculative data regarding my savings and expenditure for the financial period 2018-20, it is to submit that my total household expenditure for this period was approximately 1,23,496/- as stated in the objection. The reasons for as how I managed with such a meagre amount as stated in the objections are :*

- 1. I am single and live all alone in my government residence.*
- 2. I don't have any responsibility for meeting out the expenditure of any other person except myself.*
- 3. I believe in simple living.*
- 4. I don't own any 4 wheeler. I run on a 2 wheeler.*
- 5. I don't own any electronic equipments like air conditioner, refrigerator, induction, microwave, heater,television, room cooler etc.*
- 6. I don't have furniture like sofa-set, double bed, dining or centre table.*
- 7. I don't have any household help.*
- 8. My monthly household expenditure comprises of only fruits, vegetables and grocery which is approximately Rs. 4,000/- only.*
- 9. Apart from the above mentioned household expenditure, my other expenditure includes buying some clothes when required, travelling expenses to my hometown Prayagraj and other miscellaneous expenses.*
- 10. I have very few household items which can even be transported in a Mahindra Pick up.*

*Sir, since I have not bought all those quite expensive articles yet which are found in almost every household and due to my simple living habits and other above mentioned reasons, my yearly expenses are very less.*

*The explanation is humbly submitted for the Kind perusal and necessary directions of the Hon'ble Court."*

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2016-2018 (2016-17 & 2017-18) online against Case Id : P00018182021 (Old Case Id : 3938) and the same has been seen by Hon'ble Mr. Justice Siddharth, the then Administrative Judge, Raebareli Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 10.12.2021. As such, there is delay in submitting the same for which the officer has stated in his attachment namely "Covering letter" dated 09.12.2021, that *"the statement of property of the financial year 2016-17 & 2017-18 was to be submitted in financial year 2018-19 and 2018-19 & 2019-2020 was to be submitted in financial year 2020-2021 but due to bona-fide mistake I could not submit it in due time, I highly apologize for not submitting the same with*

*due time, I humbly request to excuse me for the same”*

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Sri Satish Kumar Magan, Civil Judge (Senior Div.), Ayodhya, be laid before Hon’ble Mr. Justice Jaspreet Singh, Administrative Judge, Ayodhya Judgeship for His Lordship’s kind perusal and orders?
