May kindly see the property statement online received from Sri Manoj Pandey, Joint Registrar (J)(Stationary), High Court Lucknow Bench, Lucknow regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 and 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 and 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2019-21 (2019-20 and 2020-21), his gross income from salary is Rs.39,15,073/- and total deductions/Savings/investments against Savings in Bank account, NPS, GIS, Income Tax, PPF, Repayment of Home Ioan and Mutual Funds (SIP) are Rs.16,62,501/-. The balance of Rs.92,553/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.23,45,125/- (Rs.22,52,572/- from salary and Rs.92,553/- from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2019-21 (2019-20 and 2020-21).

It is pertinent mention here that officer wife (Dentist) annual income was Rs.4,30,000/- for the F.Y. 2019-20 and Rs.3,00,000/- for F.Y. 2020-21 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement up to the financial years 2017-19 (2017-18 & 2018-19) online against case id: P00017682021 (old case id-3887) and same has been processed before Hon'ble The Chief Justice, High Court, Allahabad for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 and 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 and 2020-21) vide online dated 08.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 and 2020-21) of Sri Manoj Pandey, Joint Registrar (J)(Stationary), High Court Lucknow Bench, Lucknow be laid before Hon'ble The Chief Justice, High Court, Allahabad for His Lordship's kind perusal and orders?
