May kindly see the property statement received online from Sushri Deekshi Chaudhary, Civil Judge (Senior Div.), Sonbhadra regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2018-2020 (2018-19 & 2019-20), the Gross income from salary is Rs.16,37,846/- and total deductions/repayment/savings/investment against GIS, NPS, PPF and Income Tax are Rs.4,42,500/- and the balance of her savings bank account is also increased by Rs.1,80,264/- in this financial year from previous year's balance, total of which is Rs.6,22,764/-. Thus, a sum of Rs.10,15,082/- was therefore available with her to meet out the household expenditure of her family consisting three members of the financial year 2018-2020 (2018-19 & 2019-20).

It is also pertinent to mention here that the her father have annual income of Rs.60,000/- from Agriculture and her grandmother have monthly income Rs.29,500/- from pension in the above period (as mentioned by the officer).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements held at the time of joining into U.P. Judicial Service online against Case Id : P00002642019 (Old Case Id : 375) and the same has been seen by Hon'ble Mr. Justice Rohit Ranjan Agarwal, the then Administrative Judge, Firozabad Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 08.12.2021. As such, there is delay in submitting the same for which the officer for which she has stated in her online reply dated 17.04.2023, that (in her verbatim) *"with due respect I would also like to submit that due to personal and official reasons and also because of the ongoing Covid -19 pandemic I could not submit it on time. I assure that in future this won't be repeated again."*

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Sushri Deekshi Chaudhary, Civil Judge (Senior Div.), Sonbhadra, be laid before Hon'ble Mr. Justice Saurabh Srivastava, Administrative Judge, Sonbhadra Judgeship for His Lordship's kind perusal and orders?
