(1) In the financial years 2018-20(2018-19 & 2019-20), Gross income from salary is Rs.26,27,474- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF and the balance of his savings bank account(s) is enhanced by Rs.71,068/- this financial year from previous year's balance, total of which is Rs.7,25,481/-. Thus, a sum of Rs.19,01,993/- was available with him to meet out the household expenditure of his family consisting of five members in both of the financial years.

It is pertinent to mention here that his father is businessman having annual income Rs.20,00,00/-.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-20 on case id-P00015572021 online and same has been moved before Hon'ble Mr. Justice Attau Rahman Mosoodi, Administrative Judge, Ghaziabad Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20(2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20(2018-19 & 2019-20) vide online dated 09.12.2021. As such, there is delay in submitting the same in this regard Officer has stated that "He could not submit the above said statements well in time due to the heavy work load of Courts and non availability of relevant documents. He tenders unconditional apology for this delay."
