May kindly see the property statements online received from Sri Rajesh Parasher, General Manager (Law), U.P. State Industrial Dev. Corpo., Kanpur Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial years 2018-20 (2018-19 & 2019-20), Total income is Rs.52,14,970/- (income from salary including allowances, interim relief arrear of Rs.3,94,403/- & LLM three advance increment arrear of Rs.7,15,661/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, CPF, Income Tax, Insurance policies, repayment of home loan, mutual fund (SIP), FD and PPF, total of which is Rs.30,77,365/-. Thus, a sum of Rs.21,37,605/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.2,10,857/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2015-16 which had already been seen offline by Hon'ble Mr. Justice D.K. Upadhyaya, the then Administrative Judge, Faizabad in the misc. file of the officer and property statement for the financial years 2016-18 has been processed online before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar on e-service ID no-P00019702021.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide online dated 07.12.2021. As such, there is delay in submitting the same. In this regard, officer has not mentioned any reason for delay.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Rajesh Parasher, General Manager (Law), U.P. State Industrial Dev. Corpo., Kanpur Nagar be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders?
