May kindly see the property statement online received from Sri Girendra Singh, Civil Judge(Junior Division), Sonbhadra regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20) , Gross income from salary and other sources is Rs.18,40,365/- and total deductions/ repayment/ savings/ investment against PPF, NPS,INCOME TAX,MUTHAL FUND'S and the balance of his savings bank account(s) is enhanced by Rs.83,460/- this financial year from previous year's balance, total of which is Rs.9,70,547/-. Thus, a sum of Rs.8,69,818/- was available with him to meet out the household expenditure of his family consisting of three members in both of the financial years.

It is pertinent to mention here that his wife Smt Neelam is working as assistant engineer at corporate office, Bharat Heavy Electricals LTD. Salary- RS 67,000/- PER MONTH

In this connection, it is submitted that the Officer has already submitted his property statements of at the time of joining online against case id-3278 and same has been moved before the Hon'ble Mr. Justice Gautam Chowdhary, Administrative Judge, Sonbhadra for His Lordship's kind perusal and orders?

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 08.12.2021. As such, there is delay in submitting the same. for which officer has not stated any reason.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Girendra Singh, Civil Judge(Junior Division), Sonbhadra be laid before Hon'ble Mr. Justice Gautam Chowdhary, Administrative Judge, Sonbhadra for His Lordship's kind perusal and orders?
